STATEMENT

DATE: June 24, 2022

RE: U.S. Supreme Court Decision in Dobbs v. Jackson

FROM: Most Reverend John O. Barres, Bishop of Rockville Centre

We welcome today's announcement of the *Dobbs v. Jackson Women's Health Organization* decision with gratitude to God and all those who, over the last fifty years, selflessly witnessed to the sacredness of every human life. The right to life is inalienable and the foundation of every other human right.

The overturning of *Roe v. Wade* rectifies a grave injustice that has resulted in the taking of more than sixty million preborn, innocent lives and caused an avalanche of devastation to families, the dignity of women, and our culture. However, this decision does not automatically set everything right—it returns to each state the opportunity to protect the lives of those not yet born.

After a half-century of living under the flawed reasoning of *Roe v. Wade*, we should applaud the courage, wisdom, and fortitude of the Supreme Court in correcting this injustice. Just as we look back now with approval at *Brown v. Board of Education* which reversed the wrongly decided, longstanding precedent on racial segregation, we pray that one day the good sense behind overturning Roe v. Wade will be acknowledged with the same universal respect.

Unfortunately, recent legislative efforts in New York State have focused exclusively on promoting abortion. So, our work to promote and defend life with humility and compassion must continue stronger than ever. Supported by scientific advances that ever more clearly confirm the life of the unborn child, it is our God-given right and our solemn duty to proclaim the truth about abortion. We continue to work and pray that all hearts



Monthly Catholic Devotions of the Church Year

Each month of the year is dedicated to a particular devotion within the Catholic faith; the dedication of each month is based on historical events or a particular aspect of the liturgical calendar, or a combination of the two. These monthly Catholic devotions do not line up exactly with the time frame of the liturgical calendar, since they are fixed to standard calendar months rather than the Church seasons.

Some countries and areas have developed monthly dedications to devotions more specific to their area, but the following are the common, widespread Catholic devotions for each month throughout the year.

- ❖ January is the month of the Holy Name of Jesus.
- ❖ February is the month dedicated to the Passion of Our Lord.
- March is the month of devotion to St. Joseph.
- ❖ April is the month dedicated to devotion to the Holy Eucharist.
- **❖** May is the month of Mary; devotion to the Blessed Mother.
- ❖ June is the month of the Sacred Heart.
- ❖ July is the month dedicated to the Precious Blood of Our Lord.
- **August** is the month dedicated to the Immaculate Heart of Mary.
- ❖ September is the month dedicated to Our Lady of Sorrows.
- **October** is the month dedicated to Most Holy Rosary.
- ❖ November is the month dedicated to the Holy Souls.
- **❖** December is the month dedicated to The Divine Infancy of Jesus.
